<b>Currency</b>	EURO
<b>Taxes</b>	Sales Tax (VAT) - 20%
<b>Surcharges</b>	Included in the rate
<b>Collision Damage Waiver - Theft Protection (included)</b>	Damage Waiver (DW) reduces the liability of the renter in the event of damage to or theft of the vehicle. If DW is not included in the reservation, the renter has full liability for the vehicle. DW is available for purchase at the rental counter and reduces the applicable excess to zero. If purchased or included in the reservation, the excess amount is 1500€ for all vehicles with the exception of Passenger Vans, Compact Elite, Premium and Luxury vehicles which have an excess of 2500€. Economy and Compact Cargo Vans have an excess of 1500€ and all larger Cargo Vans have a 2500€ excess. Before purchasing DW it is advised to determine, if a personal coverage is adequate to cover damage, theft, loss of revenue, administration fees, diminishment of value, and any towing, storage or impound fees. If DW is declined, the renter will be required to pay these charges and seek compensation through their carrier of personal coverage. DW is not insurance. THIS IS INCLUDED IN OUR RATES

<b>Roadside Assistance</b>	Emergency contact details for 24/7 roadside assistance can be found on the rental contract. Customers should call this number if required. Dependant on the circumstances, we reserve the right to not replace the vehicle and pass on specific repair/callout charges to the customer.

<b>Roadside Assistance Protection (PBA)</b>	Roadside Assistance Protection (PBA) is an optional 24-hour emergency service. It allows customers to waive all financial responsibility for tyre (excluding rim) and glass repair or replacement costs (except when part of a larger repair), key replacement costs and all recovery and call charges imposed by a chosen roadside assistance provider as result of a fault caused by the renter. Roadside Assistance Protection does not exempt the customer from these charges if there is any breach of the rental agreement.
<b>Rate/Day</b>	EUR 5 per day
<b>Renter Requirement</b>	All drivers must present a full valid driving license. If the driving license is written in a language and characters different to those of the country of rental, an International Driving Permit is also required. Renters are advised to check whether local authorities require foreign drivers to present an International Driving Permit to avoid the risk of potential fines. Renters with licenses from countries who are not part of the International Driving Permit Agreement should carry a certified translation. All renters must provide a valid identity card or passport. All drivers must have held their full license for a minimum of 1 year. All local renters must provide proof of home address in France with a utility or phone bill. Customers picking up at Roissy Charles de Gaulle Airport must provide a local landline telephone number and a valid boarding pass or mainline train ticket showing arrival at Roissy Charles de Gaulle Airport within 24 hours of the rental start date. Please note that we reserve the right to request additional ID or conduct further identification checks if needed which may include an identity check with an external organisation. Upon the United Kingdom leaving the European Union (EU) the requirements for UK Driving license holders driving in EU member states may change. Please check requirements before travelling. <b>Age Requirements</b>	All drivers must be at least 25 years of age to rent a vehicle. Renters aged 21 to 23 may rent the car categories Mini and Economy. Renters aged 24 and older may rent the car categories Compact, Intermediate, Standards, SUVs and Passenger Vans. Cargo Vans may be rented from age 23. An additional charge applies to renters under 25 years of age.
<b>Rate/Day</b>	Young drivers are charged at €32 per day with a maximum of €320 per rental.

<b>Payment Policy</b>	All major credit cards (issued by either Visa, Mastercard or American Express) are accepted. Prepaid cards, Diners club and Discovery card are not accepted. All cards presented must be in the renter's name. A security deposit plus the estimated cost of the rental will be taken at the time of rental. For the car categories Mini to Standard and Passenger Vans a deposit of 250€ is required. For Convertibles, Premium and Luxury vehicles the deposit is 1000€. Cargo Vans require a deposit of 500€. Cash and 'cheques vacances' are accepted as forms of payment but only at the end of the rental. The initial charges must be taken on a valid debit or credit card.
<b>Additional Driver</b>	Additional drivers must meet all renter requirements. They must appear at the rental counter with the primary renter and sign the rental agreement. Additional drivers can only be added to the contract at the pick up branch. Additional charges will apply.
<b>Rate/Day</b>	Additional drivers are charged at EUR 12 per day, Tax included, with a maximum of EUR 120 per rental.
<b>Infant Seat</b>	Baby seats (1 ~ 3 YEARS) are available at the cost of 12.- € per day, max of 72.- € per rental, VAT included.

<b>Child Safety Seat</b>	Baby seats (1 ~ 3 YEARS) are available at the cost of 12.- € per day, max of 72.- € per rental, VAT included.

<b>Child Booster Seat</b>	Child booster seats (4+ YEARS) are available at the cost of 8.40 € per day, max of 50.40 € per rental, VAT included. They must be pre ordered at the point of reservation, available on request. Customers will be required to fit the child seat themselves. Child seats have a replacement fee of €130.00.

<b>Cross Border Policy</b>	Vehicles can be driven in Andorra, Austria, Belgium, Denmark, Finland, Germany, Great Britain, Italy, Liechtenstein, Luxembourg, Monaco, Netherlands, Norway, Portugal, San Marino, Spain, Sweden and Switzerland. No additional charges apply. Vehicles can also be driven in Corsica, Sardinia and the Balearic Islands but must be returned to France mainland. Customers must always inform the rental branch of their intention to leave the country with the vehicle and require authorisation. Cross border is free of charge.
<b>Oneway rentals</b>	All rentals where the vehicle is not returned to the same location as it is collected will be subject to a one way fee. One way rentals are allowed within mainland France only.
<b>Refueling Policy</b>	Renters must return the vehicle with the same fuel level as at the time of pick up. If the vehicle is not returned with the same level of fuel the renter will be charged a refuelling service charge based upon the fuel used. An additional fee of 15€ will apply. The renter may choose to prepay for the refuelling service charge at the time of vehicle collection. Please contact the local branch for details.
<b>After Hours</b>	Please contact the local rental branch to enquire about after hours rentals and returns. Additional charges may apply.
<b>Delivery and Collection</b>	Please contact the local rental branch to enquire about delivery and collection. Additional charges will apply.
<b>Maximum days of rental</b>	There is no maximum length of rental, however the customer will have to go to a local branch every 28 days to have the condition of the vehicle checked.
