<b>Renter Requirement</b>	<p>Valid International or EU Driving License held for at least 12 months, ID Card or Passport is required.</p> <p>National driving license must be presented along the international driving license.</p> <p>For Greek residents a passport is not mandatory however ID Cards are required.</p>
<b>Age Requirements</b>	Minimum rental age is 21 for all car groups. For car groups Compact (CDMR, CDAR, CXMR, CFMN), Intermediate (ICMR, IDMR, IFMR) Fullsize (FVMR) and Premium (PDMR) a young drivers fee of 18.60 EUR per day applies for drivers aged 21-22. The young driver fee does not apply for car groups Mini (MDMR) Economy (EDMR, EDAR) and Compact 2-4 door (CCMR). The maximum rental age is 75.
<b>Payment Policy</b>	<p>ACCEPTED METHODS OF PAYMENT: Visa, Mastercard and American Express credit cards are accepted. All cards presented must be in the renter's name. A security deposit will be blocked on the credit card and the estimated cost of the rental will be charged at the time of rental. The blocked deposit on the credit card will be released upon acceptable return of the vehicle and notification of the cardholder's bank.</p> <p>The car categories Mini, Economy, Compact and Intermediate require a deposit of 290€, Standard and Fullsize vehicles and Cargo Vans require a deposit of 390€ and Premium and Luxury vehicles require a 1000€ deposit.</p> <p>Debit cards, prepay cards and Unionpay are accepted as forms of payment but only at the end of the rental or to purchase additional products. The initial charges must be taken on a valid credit card. Unionpay is not accepted in Halkidiki, Kos, Milos, Mitiline, Lesvos, Patra, Santorini and Zakynthos. <b>Cross Border Policy</b>	Out of country rentals: Renters may drive the rental car to certain countries outside of Greece. Restrictions do apply. Out of country rentals require prior approval and are charged an additional 10 EUR per day with a 90 EUR fee for the green card. Out of country rentals are allowed only into following European Countries: Andorra, Belgium, Bulgaria, Bosnia, Denmark, Finland, France, Gibraltar, Germany, Great Britain, Ireland, Liechtenstein, Luxembourg, Monaco, Netherlands, North Macedonia, Norway, Austria, Portugal, Sweden, Switzerland, Croatia, Italy, the Vatican, San Marino, Poland, Romania, Slovakia, Slovenia, Serbia, Czech Republic, Fyrom, Hungary and Spain. Out of country rentals are not allowed to other countries not mentioned above. Process and publication of green card: The minimum time of the publication of a green card is 5 working days. The green card covers the rented vehicle with basic insurance (T.P.I.) as long as it remains in the borders of the country for which it is issued. Roadside assistance or car replacement while driving abroad is available.
<b>Oneway rentals</b>	This is on request service and is available in specific locations in Greece. All rentals where the vehicle is not returned to the same location as it is collected will be subject to a one-way fee. One-way rentals must be requested at the time of booking. Unauthorized one-way drops will be charged at the end of the rental. The one-way fee must be paid at the rental counter.
<b>Refueling Policy</b>	Refueling Policy: The rental vehicle is supplied with a full tank of fuel. The vehicle should be returned with the same amount of fuel otherwise the difference shall be charged to the renter according to the official market fuel price.

<b>Delivery and Collection</b>	DELIVERY AND COLLECTION: Delivery and collection is available during office hours within city limits up to a radius of 15 km with a charge of 22.32 EUR per service. Delivery and collection service outside of city limits over the 15 km radius but up to a maximum of an extra 11 km will incur an additional per km fee of 0.74 EUR in addition to the 22.32 EUR service fee. A delivery and collection service fee of 31 EUR applies for Araxos Charter International Airport which is approximately 40 kms from the city of Patra. A service fee of 22.32 EUR applies for deliveries to and from Piraeus Port by our Athens Downtown branch. Deliveries to and from Rafinas and Lavrios harbours serviced by our Athens Downtown office will incur a service charge of 43.40 EUR. All fees quoted include VAT.
