<b>Taxes</b>	VAT 23% per rental
<b>Surcharges</b>	Government Admin Rental Fee (GARS - Government contracts only) 4,03 EUR per day PTAP - Portugal Airport Fees 23,58 EUR per rental. <b>Collision Damage Waiver - Theft Protection (included)</b>	CDW collision damage waiver limits the renter's financial responsibility for loss and damage to the rental vehicle. <b>Personal Accident Insurance (PAI)</b>	PORTUGAL MAINLAND, MADEIRA AND AZORES - PAI Personal Accident Insurance covers the passengers and driver in the event of death or total permanent disability up to a maximum of EUR 15,000 and medical expenses up to a maximum of EUR 1500. The cost of PAI is EUR 5,57 excluding VAT per day for all groups up to a maximum of EUR 83,57 per rental.

<b>Theft Protection</b>	TP theft protection limits the renter's financial responsibility for loss by theft of the rental vehicle. <b>Age Requirements</b>	<p>PORTUGAL MAINLAND: Minimum rental age is 18 years for vehicle groups: Mini MCMR, Economy EDMR and Compact CDMR.</p> <p>A young drivers fee of EUR 7,70 per day up to a maximum EUR 77,00 per rental for drivers aged 18 to 20 years is applicable only on vehicle groups Mini MCMR, Economy EDMR and Compact CDMR. Two valid credit cards. 2. Return ticket to the country of origin.</p> <p>DEPOSITS: All customers are required to place a deposit taken in the form of a credit card authorization. Deposits will be blocked on the credit card in a total of 300 EUR for Economy and Compact groups and 600 EUR for the remaining groups. This deposit is blocked on the credit card, regardless of customers accepting or not the Super CDW or excess reduction. This deposit is made at the beginning of the rental for missing fuel, additional days, damages, services, etc. If at the end of the rental there is some amount to charge relating to any of the mentioned items, this deposit will be used. In case the amount to be charged, at the end of the rental, is higher than the deposit amount, the driver is responsible for the payment of the outstanding amount.</p>

<b>Cross Border Policy</b>	<p>PORTUGAL MAINLAND: Cross Border policy - Rental car may be driven into any European Economic Community Country and Switzerland but must be returned to an Enterprise location in mainland Portugal. Rental vehicles cannot be driven into any Eastern European or African countries with the exception of Slovenia and Slovakia, as well as others specified in the International Motor Insurance Card. The rental vehicle is also prohibited from ferry travel to the islands of Madeira and Azores from the Portuguese mainland as this is not covered by insurance.</p> <p>CROSS BORDER FEE (GREEN CARD):</p> <p>This product allows the Guerin-Enterprise rental vehicle to travel outside of Portugal in accordance to the cross border conditions specified in the green card. The rental vehicle should always be returned to the original pickup location in Portugal.</p> <p>The cost of this product is EUR 73,80 per rental. If renter's drive the rental vehicle cross border without prior authorization and without payment of this supplement they will be penalised EUR 3,69 per km effective from the beginning of the rental and will be responsible for any damage occurred to the rental vehicle.
