An additional young drivers fee of 5.00 EUR inclusive of VAT will apply and a reservation notice period of 48 hours. In the event of rental vehicle damage an additional excess of 800 EUR applies even if the renter purchases additional insurance coverages.
Payment Policy	Visa, Diners and Mastercard credit cards are accepted. All cards presented must be in the renter's name. A security deposit will be blocked on the credit card and the estimated cost of the rental will be charged at the time of pickup. The deposit will be released by the cardholder's bank upon notification of return of the vehicle. The car categories Mini, Economy and Compact require a deposit of 290.00, Intermediate & Standard vehicles have a 390.00 deposit and Fullsize & Luxury vehicles require a 1000.00 deposit.
