The vehicle will be inspected by an employee the next business day and customers will receive a confirmation after the vehicle has been checked-in. If a customer wishes for a member of staff to be present during return outside the opening hours between 11pm and 7am, an afterhours service charge of 30.00 EUR including VAT will apply.
